 The hearing is being held to consider a dimensional variance request that was submitted by the applicant, Mary Queen of Apostles Parish. This request is for a dimensional variance from the sign area limitation of 20 sq ft for a digital sign in the residential zoning district, so as to permit a sign with a maximum area of 24 sq ft. The applicable zoning ordinance section is 3.24 (b)(1)

The subject lot is permanent parcel number 41-03-05-202-010 with a street address of 1 W. Maple St., Sand Lake, MI 49343 (Kent County, Michigan)

Parks and Rec Update: 18 yards of mulch are being donated for the park. DPW believes about 12 more yards will be needed. Motion made by Merritt to purchase mulch in addition to what is provided up to 30 yards. Seconded by Wright. Motion Carried.
