- *Janice Boyd, Why have we lost confidence with Rachel?
- *Tracy Quinlan, Asking Rachel this question but telling her she doesn't need to answer-Did you get a letter with a 30 day(straighten up) notice that you need to work with Village better. Saying we spent a lot of money with attorney on contracts. We want to wipe out everything last council did. Agrees with Chad, and the others on disappointment and making serious mis-stake.

Connallee Kleck, Interactions with Rachel have always been pleasant and done job well. Need more consideration in this and not just taking someone's job. Work with person more with conflict resolutions and not just fire.

Jerry Dines, was DPW Supervisor of Village for over 10 years and wanted to give input of what happened with previous council(all employees working well together). When Tracy came on as President she took Brenda (treasurer over 20 yrs.) and myself in office as she sat on desk, telling us she was new sheriff in town and if we don't like it theirs the door as she pointed to door.

Samantha, asking if contracts were legal? Mollie replied we were unable to speak on those for legal reasons. She understood. Asking if keeping clerk/treasurer together?

Bruce Avery, Appreciate what we are doing and likes the fact of not having clerk/treasurer together because you do not have checks and balances. No comment on Rachel, because he understands the council cannot.
