F&V Operations has been called out numerus times to work on it. DPW Supervisor would like to purchase new pump. Old pump will be rebuilt next FY and held on to as a spare. Motion made by Wright to allow the purchase. Seconded by Christensen. Motion Carried.

9. Public Comment (Limited to 3 minutes per person):

a. Resident states they are in favor of a full-time fire fighter if that means quicker response times. Also would like to make the suggestion of the council looking into adding a tire swing in the park.

10. Council Comment:

- Christensen wondering about hydraulic pump for leaf trailer- new pump was installed today and DPW will test it out tomorrow.
- Helton was wondering about update on lift station- Doerr just heard back from engineer and has prices of \$720,000 and \$910,000 for 2 options. Doerr also filed intent to apply with EGLE for any future grants that may come from them.
- Wright asked Pastor Jorge Ballivian to schedule the prayers for the upcoming council meetings.
