## 4. Comments by the President:

President Quinlan did not have any comments.

#### 5. Public Comments:

Public comment was opened at 7:03pm. Maggie Merrit (resident), head of the Sand Lake Museum Historical Society, inquired as to whom oversees the payment of the electric bill at the Museum. (The Chamber of Commerce takes care of this.) Matt Baczewski (non-resident) spoke about his concerns with Sable Homes coming to Sand Lake. Feels like the Council should have due diligence in researching Sable Homes and should find someone more suitable for the Village to have build in Sand Lake. Public comment closed at 7:05pm.

## 9. Report by Trustee Gokey on Website Manager:

a. I.T. Right owns VoSL's domain name: By suggestion of Trustee Parkhurst the owner of <a href="www.villageofsandlake.org">www.villageofsandlake.org</a> domain name was researched. I.T. Right owns the rights to our domain name. We will continue utilizing their company.

## 10. Kent County Community Development Grant:

- a. **Dog park**: Two Village residents will be working with Trustee Jerome on getting estimates and creating a draft of the plans for the dog park. They will also be researching ideas for what should and should not be in the park. Rich Opper was kind enough to give the Village permission to remove the horseshoe pits so a dog park would be in Salisbury Park. The plan is to write a Community Block Grant for this project.
- b. **Digital speed signs**: The Village would like to have a portable digital speed sign. If funds remain in the Police budget it will be used to purchase the speed sign. Otherwise a Community Block grant will be written for this item. If the Village purchases the digital speed sign the grant will be written for a digital park sign instead. All options are currently being researched.
- c. **Benches/planters**: A Community Block grant will be written for permanent benches and planters in the Village. The Parks and Rec committee is comparing prices and styles.

Discussion was also had that the process for drafting the initial plan for the potential boat launch improvement and parking. All proper steps will be followed to ensure security and safety of all.

# 11. Department Reports:

# a. Fire Department:

The annual Halloween Party will no longer be held in the Fire Department. The Village would love to see an organized Village of community events were everyone is working together for the Village. It was suggested that perhaps a Trunk or Treat event could be coordinated on 5<sup>th</sup> Street. Motion Made by Parkhurst, with support by Baker to file the September 16<sup>th</sup>, 2019 Fire Department report. AIF. Motion Carried.

#### b. Human Resources:

i. Motion needed to add Rachel Gokey as signatory on bank accounts. Motion Made by Parkhurst, with support by Baker, to appoint Rachel Gokey as a signatory on all Village bank accounts. AIF. Motion Carried.

### e. Cemetery/Parks and Recreation:

Discussion was had about a stump needing to be removed and a hole needing filling. A community clean up day is coming to remove more low hanging branches. Volunteers are needed and appreciated. A date has not been selected at this time.

# f. Finance & Budget Zoning and Ordinance

- i. Delinquent water and sewer bills
  - 1. Timing of collection letters
  - 2. Timing of shut-off notices

It was just brought to the attention of the Village Council that there are several outstanding water, sewer and/or tax bills in the Village of Sand Lake. This includes both residents and businesses. Discussion was had about how the Water and Sewer bills as well as tax bills are collected and how they are handled when overdue or late. There is an ordinance in place stating how delinquent taxes and water/sewer bills are to be handled including when water is to be shut off for nonpayment. Residents will be receiving reminder letters for any delinquent bills due to the Village of Sand Lake.

Motion Made by Baker, with support by Parkhurst, to approach the Township about a 50/50 cost split on a building analysis, to be done by a structural engineer, before any large financial decisions are made about the building. AIF. Motion Carried.

  - b. **KCDC Petition for Maintenance and Improvement of Drain**: Motion Made by Parkhurst, with support from Gokey, to give President Quinlan

permission to sign the KCDC Petition for Maintenance and Improvement of Drain. AIF. Motion Carried.

c. **Village of Sand Lake v Paul Collins:** Motion Made by Gokey, with support by Baker, to authorize the process of foreclosure to begin on Paul Collins property immediately. AIF. Motion Carried.

## 13. Council Comments:

Trustee Parkhurst inquired if there was any council member able to attend the seminar on how to grow from a Village to a City. No one was able to attend this fall but will investigate the next scheduled date and time.
