- 3. Adoption of Agenda: Motion made by Helton to adopt the agenda. Seconded by Latham. Motion Carried.
- 4. Presidents Report: Doerr went over pacer ratings of the roads in the Village and how much they have gone down even in that last year. MDOT gave funding for a smaller road project for the Village. The Council is aware of how bad E. Lake is. E. Lake project is approximately one million dollars and after meeting with the State Senator hopefully there will be funding for that project soon.

Bill Cornelisse also spoke during this time. The DPW Supervisor spoke about the Village water, storm drains, and sewer systems, how they work, how they have improved, and how they could continue to improve.

 - a. Resolution 2023-10: Motion made by Helton to pass Resolution 2023-10. Seconded by Merritt. Roll Call: Doerr: Yes
 - b. Porta Potty at Pavilion/White Pine Trail- The last 2 years Deans Excavating has paid for a porta-potty to be placed by the White Pine Trail. The council would like the DPW Supervisor to check into prices and also ask about if vandalism has been an issue the last 2 years. Motion made by Merritt to table until next month. Seconded by Helton. Motion Carried.
 - c. Discussion on grass cutting and weed control: Motion made by Latham to have the Zoning Administrator take with the attorney to come up with a draft ordinance for the council to review. Seconded by Helton. Motion Carried.

Resident is concerned, he thinks the Granger trucks are bigger than the other garbage trucks previously.

Business owner is concerned about the speeding cars on W Lake by the park. Wondering if the Village can make sure police patrol that area.

Resident is wondering if the Village knows anything about the sale of the elementary school in town.
